(COVID-19) at the 2020 common shareholder meeting

Due to the spreading of novel coronavirus 2019 (COVID-19), the company is concerned

about this situation and would like to inform about the guidelines for attending the common

shareholder meeting as follows.

1. For shareholders who belong to the high risk group i.e. those recently traveled to or

returned from high risk countries or show respiratory symptoms, the company

reserves the rights to refuse their attendance at the meeting. In this connection, such

shareholders can authorize others or the company's independent directors to attend

the meeting on their behalf.

2. Shareholders can submit the authorization documents or ask questions about the
